

# Information on Early Graduation Applications

## Early Graduation



- Students who have excellent academic records and wish to graduate early may apply for early graduation based on the following requirements. The requirements for early graduation are the same as those for regular graduation.
- **Early Graduation Requirements**  
: Degrees will be awarded to students who meet all regular graduation requirements for their department or major and have a cumulative GPA (including F grades) of 4.0 or higher.

[Excluded Departments] **College of Medicine, College of Nursing, College of Engineering, School of Architecture, College of Music**

 **Application period** for students who wish to graduate early in February 2025: **Sep 2-4, 2024 (Monday- Wednesday)**

## Qualifications for Application (Necessary Requirements for Application)




### ※ Qualifications for Application

A) Until 2016 entrant students: Individuals who have completed more than 5 semesters after admission, have acquired a total of 105 or more credits, and have a cumulative GPA of 4.00 or higher, including summer and winter sessions

B) From 2017 entrant students: Individuals who have completed more than 6 semesters after admission, have acquired a total of 115 or more credits, and have a cumulative GPA of 4.00 or higher, including summer and winter sessions

## How to Apply



🕒 Only students who wish to graduate within the current semester can apply for early graduation.

🕒 Since early graduation applicants **are not considered students who are expected to graduate at the time of application, all applicants must register for a minimum of 10 credits.**

➡ When the college approves the application for early graduation, applicants become students who are expected to graduate in the current semester.

🕒 Early graduation applicants **cannot earn credits through credit exchange programs.**

- However, credit exchange in virtual university courses, which are taken through the Center for Smart Teaching and Learning, approved by our university, can be earned.

🕒 Early graduation applicants will also be evaluated for graduation based on the credits earned in all terms, including the winter semester of Academic Year 2024.

**- However, Community Service courses offered in the 2024 Winter Semester will be excluded.**

🕒 **The approval of an application for early graduation does not guarantee graduation.** Applicants must meet the requirements for early graduation to be eligible.

🕒 If applicants for early graduation fail to meet the graduation requirements during the semester for which they applied, **they will be disqualified from early graduation.**

➡ Applicants must complete the remaining coursework during the following semester and **will be excluded from the scholarship selection.**

※ If early graduation applicants in the sixth semester fail to meet the requirements, they can reapply for early graduation in the 7th seventh semester (Starting from 2017 entrant students, early graduation application is only available in the seventh semester).



## Ineligibility for Early Graduation



- If applicants fail to meet any of the graduation requirements, they will be disqualified from the graduation review.
  - ※ Some students misunderstand the eligibility for early graduation as the graduation requirements.
    - > To graduate early, students must meet all applicable graduation requirements.
- If a student's cumulative GPA (including F grades) is below 4.0 at the time of graduation for the semester, the student will be disqualified from the graduation review.
- Students who have completed a double major or minor but do not meet the degree requirements for the relevant course will be disqualified from the graduation review.  
(They will be excluded from early graduation eligibility.)

 To cancel the early graduation, students must apply with their college administration office before the final exams.

- The administration office will determine whether to cancel the early graduation and proceed with the necessary procedures with the academic affairs team.
- They may be excluded from consideration for the scholarship selection.

 Early graduation candidates are **not eligible to apply for a deferral of degree completion (graduation postponement)**.
